6. Be sure to pay your camp balance before May 27!

Camp balances are due on May 27. Log into your MyGS account to see your balance due. You can make partial payments at any time in your account. If you sold Girl Scout cookies last year, you can apply 2021 cookie program credits to your balance due by calling Customer Care - remember that your unused credits will expire on March 31, 2022.

Are you selling Girl Scout cookies this year? Your 2022 cookie program credits can be applied to your balance due when they are issued in early May, so you'll have time to apply it to your balance due before the camp balance due deadline.
