Climbing Tower and Adventure Challenge/Low Ropes Activities

The following activities have limited availability due to staffing requirements. Please allow at least a month notice for us to staff these activities for the time period you are interested in. There is also a waiver that must be signed by all participants and for those under 18 years of age by their parent or guardians. Climbing Tower at Camp Farnsworth (2 hours for \$200 and then \$75 for each additional hour)

A two-hour rental includes: 1/2 hour of safety training, equipment orientation and harness fitting, and then 1 and 1/2 hour of climbing. Price includes set up of tower, all necessary safety and climbing equipment, and two staff members to facilitate and belay. Maximum group size is 20 people. Depending on climbing ability, age and interest, a group of 15 can normally climb twice in an hour and a half session.
